Teva works with many organizations that advocate for patients around the world. Patient organizations and advocacy groups represent the needs of people living with medical conditions and provide healthcare companies with important advice from their own perspectives. Interacting with patient organizations enables Teva to understand the many ways health impacts life, inspires us to discover new possibilities in the development of new medicines and more.

In all of our interactions, Teva is committed to working in an ethical and transparent manner. When working together with patient advocates and groups, our behavior is characterized by the spirit of partnership, mutual respect and trust, openness and transparency, with an overarching commitment to bring benefits to patients and their families in a sustainable fashion.

Teva endorses the European Federation of Pharmaceutical Industries and Associations (EFPIA) and Medicines for Europe (formally the European Generics Medicines and Biosimilar Association) codes of conduct which provides standards for the relationships the Pharmaceutical Industry and Patient Organizations. In accordance with this code, Teva will annually disclose its relationships with patient organizations in Europe and fully complies with all legal and statutory requirements regarding the disclosure of patient group support as a minimum standard in any country.

Recognizing the importance of transparency and its role in developing trust-based relationships with stakeholders, the public and, more importantly, patients, Teva voluntarily discloses across **65** countries as part of its goal towards global transparency.

Of the 65 countries, Teva Pharmaceutical Industries Ltd confirms that the following 37 countries did not undertake any patient organization interactions during 2016: Argentina, Albania, Belgium, Bosnia-Herzegovina, Brazil, China, Cyprus, Dutch Antilles, Estonia, Finland, Hong Kong, Iceland, India, Indonesia, Japan, Kazakhstan, Kosovo, Liechtenstein, Luxemburg, Macedonia, Malaysia, Malta, Monaco, New Zealand, Portugal, Romania, Russia, Serbia, Singapore, Slovenia, Sweden, South Korea, Thailand, Ukraine, Uruguay, Vietnam, Venezuela.

Global & European Patient Advisory Boards

In May and November 2016, Teva hosted two *Improving Health Global Patient Advocacy Dialogue* meetings in Amsterdam. The primary and ongoing purpose of the *Improving Health, Global Patient Advocacy Dialogue* initiative is to build strategic relationships with the patient community and their trust in Teva, by enabling the patient voice to be heard within the business decision making process. Through these strengthened relationships with patient organizations, we will be able to better understand the many ways health and illness impact people's lives, and to work collaboratively to deliver solutions that will enable them to have greater control over their health.

- From Europe, Teva was joined by the European Brain Council, the International Alliance of Patient Organizations (IAPO), the European Patients Forum, the MS International Federation, the Global Allergy and Asthma Patient Platform, the European Huntingdon's Association, A Sister's Hope, the World Heart Federation, the Union of International Cancer Control (UICC), the Parliamentarian Diabetes Global Network, and the International Diabetes Federation.
- From the USA, Teva was joined by the US Pain Foundation, the Men's Health Network, Healthy Women, For Grace, the International Alliance of Caregiving Organisations (IACO) and Melinda Kavanaugh from the Helen Balder School of Social Welfare.

In October 2016, Teva hosted a respiratory patient group advisory workshop. The primary purpose of the meeting was to seek advice and understanding from patient advocacy groups on the subject of Teva patient support programs. Seeking to identify if the programs met patient needs and what further development could be undertaken to support patients.

• From Europe, Teva was joined by the European COPD Coalition, the Patient Information Forum, Asthma UK and the European Federation of Allergies and Airways.

For all advisory boards listed above, the participants were offered €750 per day as an honoraria which was accepted or declined in accordance with their organizational statutes. Additionally, Teva paid for accommodation and expenses to participate within the meeting.
